

This Artist-Agent Agreement (the 'Agreement') is effective from **DATE** and is an Agreement between **ARTIST NAME** (the "Artist'), an individual with their main address at: **ARTIST ADDRESS** and **Loxlea Creative** (the 'Agent'), an entity with its main address located at: **7/59 Smith St Cleveland 4163 QLD Australia**

□ The Artist agrees to appoint the Agent to be their <u>exclusive</u> worldwide talent agent for the purposes of securing performance contracts in the fields of Film, T.V., Musical Theatre, Live Theatre and any other avenue negotiated by the Artist and the Agent.

OR

□ The Artist agrees to appoint the Agent to be their <u>Acting</u> worldwide talent agent for the purposes of securing performance contracts in the fields of Film, T.V., Musical Theatre, Live Theatre and any other avenue negotiated by the Artist and the Agent. The Agent understands that the Talent has another Agent that handles any or all of the following: Extra work, Commercial Face work, Modelling and Promotional work.

The Agent agrees to:

- use their best efforts in representing the Artist, submitting the Artist for contracts and or career opportunities.
- negotiate the terms of any assignment that is offered to the best of their ability, with the understanding that the Artist has the right to reject any assignment if they find the terms thereof unacceptable.
- Use best practice methods of handling the Artists fees from jobs. All Artist fees are deposited into a separate business bank account in the interest of transparency.

The Artist agrees to:

- perform every successful contract fully to the best of their ability and in a professional manner.
- inform the Agent of any changes to their appearance or their personal details as soon as they occur.
- make every effort to attend all castings, auditions, meetings or interviews arranged on their behalf by the Agent.
- inform the Agent of any changes to or restrictions upon their availability as soon as they are known.



- consult with the Agent prior to entering into any agreement or contract that may impact their ability to carry out any of the above.
- treat all materials and information provided to them during the course of this agreement as strictly confidential at all times.
- not share or distribute any information concerning upcoming projects, casting briefs or casting advice with any third party.

It is agreed that the Agent is entitled to a 10% commission on all contracts negotiated on behalf of the Artist, plus appropriate GST as it applies to each particular contract. On contracts longer than 5 weeks the Agents entitlement drops from 10% to 5% after the fifth week of the contract. The Agent is entitled to deduct from the sums received on behalf of the Artist any direct expenses incurred on behalf of the Artist. All such expenses will be agreed to in writing by both the Artist and the Agent prior to the incurring of these expenses.

It is acknowledged that this is an open contract and can be terminated by either party in writing with 30 days' notice. The Artist acknowledges that if they terminate this agreement, the Agent is entitled to a continued percentage of all historical contracts negotiated during their association with them, for the term of each specific contract.

Both parties agree that the Agent is acting as an independent contractor.

This agreement is not an employment agreement, it does not constitute a joint venture or partnership between the Agent and Artist.

All amendments to this contract must be in writing.

This agreement shall be governed by the laws of the state of Queensland, Australia.
